#### Learning to speak the language of the heart

Doug suggested a topic for me for this newsletter a couple of months ago, but like so many things in the past few months, I lost it. Actually, I lost it, found it, and lost it again! I think gremlins have moved into all of my electronics! Anyway, I was thinking about the current Conference Theme of "Communication and Participation ...", my brain stuck on communication and my first sponsee came into my mind. This was a woman who was just getting out of treatment, I was about a year sober and up to Step 8 or 9. She was also from La Verkin; she was on a 2<sup>nd</sup> trip through this facility and they weren't going to release her without a sponsor. A guy from my home group was attending meetings at that center at the time and asked me if I would go meet with her and hopefully sponsor her. My sponsor thought it was a great idea, so I agreed.

I have to tell you, as best as I could see, we had NOTHING in common. While she was an alcoholic, her drug of choice after her last relapse was meth. Drugs were never more than incidental in my history, with my drug use the last several years of my drinking comprising of smoking a joint about once a year. I didn't know anything about meth at the time. She was older than me; she was very loud, swore a LOT and was totally hyper. I've never considered myself particularly loud, my mouth stays pretty clean unless my spirituality is in the toilet, I think I'm pretty mellow, and certainly was compared to her. I didn't know how to take someone through the Steps, and my primary functions as her sponsor seemed to be to talk her down when she called me, regularly, about to explode about something, and to take her to meetings. Sometimes I would be shaking by the time I hung up the phone with her because it was so hard for me to not get wound up to her level, and due to some of my past history, I have a hard time, especially back then, being around loud people. For me, someone yelling or even talking very loud to me used to mean I was going to take a beating, and I was several years sober before I could talk with someone who was loud without my body going into fight or flight. But she kept calling, I kept taking her to meetings and giving her the suggestions that had been given to me - to say "help" in the morning, "thank you" at night, read the Big Book, call me, etc., which she did.

After a few months of this, I was going to Salt Lake for something. She asked if she could come with me because she wanted to visit her mother. I was horrified at the thought of spending 8 hours in the car together, but I couldn't say no ... she didn't have a drivers license or vehicle, and she was asking to see her mother. I said yes. Well, that trip changed a lot for me. We talked at a whole different level, and I was able, finally, to see our similarities instead of just our differences, and I don't know about her, but that was a lesson I carried with me. It's easy to hear the words "look for the similarities", but until I have the experience, they're just words. That trip took the words in my head and turned them into a knowing in my heart.

I have no idea what the point of writing this was, but after two days of staring at it, wanting to write something else, and having nothing come up, I decided there must be a reason and I quit resisting. It may not have anything to do with communication as it relates to the conference topic, but maybe it has a little to do with what we do best in Alcoholics Anonymous, learn to speak the language of the heart. ## **Corrections Committee Report**

Dear Fellowship;

The past few months have been increasingly busy as we've reviewed and discussed the agenda items on Corrections for this year's General Service Conference held in April in New York City. Area 69 Alcoholics Anonymous was invited to attend and present displays and literature for the Seviere Valley Substance Abuse Conference held in Richfield, Utah (District 6) on March 19, 2008. I also had an opportunity to visit Fillmore, Utah (District 4) for a barbeque and speaker meeting on March 18, 2008.

The Fillmore County Jail has several meetings per week and has good attendance as well as great support from Correctional professionals within the facility. The volunteers there, as is the case for most volunteers who carry out this kind 12<sup>th</sup> Step work, are so committed to carrying the message of hope and recovery to the inside member thus increasing their possibility for sustained sobriety once they are released.

District 8 (Great Basin area; North Eastern Utah) has been actively planning the 2<sup>nd</sup> annual Area 69 Bridging the Gap (BTG) workshop being hosted in Vernal June 21, 2008. This is a one day event and is a great opportunity to share and gather information and experience on 12<sup>th</sup> Step work when an AA member is being released or transitioned from a correctional facility or treatment institution into the outside community. It has been documented that

when a newly released member attends an AA meeting within the first 24-48 hours of their release, their opportunity to stay sober is increased by 100% verses a substantial decrease of his/her chance of sobriety after this crucial time period. The BTG program has been developed to have outside AA members help these newly released members make a smooth transition into the Fellowship of Alcoholics Anonymous in their communities throughout the US and Canada, and anywhere around the world where AA is available. Please mark this date on your calendar to learn more about how you can be involved and/or bring information to your District.

Gap Workshop Weekend will be held in Kansas City, MO September 5-7, 2008.
