Treatment Facilities, Bruce I., Chairperson - Last Month I tagged along with Monte and Wade to visit District 8. One thing we discovered was that there maybe a lack of understanding in their communities about alcoholism. Some of the Area Standing committees have been discussing ways to help them to raise that awareness. A few weeks ago I had the privilege of attending a treatment workshop hosted by District three. It was a good conversation about treatment related topics, especially Bridge the Gap. Good for me because it is a project I have devoted a lot of my time to recently. Talking about it helped me understand what we need to do to clarify and administer the program. It helped me understand the value of our literature and that perhaps I could offer them packages for specific needs. The following week I attended a corrections workshop held by District Two. Once again the topic of BTG was addressed. Sara L. gave a great presentation of how BTG works and how it could be improved in their district. Sara is also a member of the BTG Ad-Hoc committee and her input has been extremely valuable. We found out at the workshop that in many cases inmates in their district are turned loose on the spur of the moment, which puts making bridges difficult. It made us consider how we might use the Central Offices for help with cases that need an immediate temporary contact. This presented one more consideration for the BTG Ad-Hoc committee to look at. I have prepared some packets for them to take in/re to BTG and for treatment volunteers. I am please to report that over half of the districts have active treatment chairs and committees. It is important
to keep in mind that treatment centers still provide one of the best environments to find future AAs. And that means our presence there will likely influence many to join in our fellowship for their long term sobriety. Once again this suggests Bridging the Gap, so we can be there when someone reaches out for help. Another possibility for treatment committees is cooperation with corrections committees in the drug court programs offered by the State. I do not know much about the programs yet, only that they have strong support for the government as a better solution than simple confinement.

PRAASA Defrayment Ad-hoc Committee, John G. - Our Ad-hoc committee has met twice since our last report to the area. We have made great strides in coming up with a formula by which we can get all of our standing chairs defrayed to attend PRAASA without raising the existing area budget. All the members of the committee feel that getting our standing chairs defrayed to attend PRAASA will have good and lasting impact on the area; again, with no impact on the area budget. We plan to meet again at the PreAssembly Workshop and to have finalized proposal to submit to the area at the Fall Assembly.

Correction/Treatment-Bridge the Gap Ad-hoc Committee, Bruce I. - We have been reviewing and in some cases rewriting material for the District Workbook. We brought some updated documents with us to be used and reviewed by the districts prior to June. Our hope is to have a good discussion at the Bridging the Gap Workshop regarding the changes we are suggesting and gain a consensus for the Area about the Bridging the Gap guidelines. We realize there are many among us with this type of experience and that they will be able to review our work and make suggestions in return. Our goal is to make the information uniform while allowing districts the flexibility to adapt the guidelines for their own needs. While discussing the Bridging the Gap program in committee, it became clear to us that each district has unique characteristics and challenges when it comes to the institutions within their boundaries. We believe strongly in having districts operate autonomously, sharing their volunteer databases periodically with the Area. And that role of the area should be limited to information gathering and sharing. The two committees, Corrections and Treatment, bear the responsibility of educating and offering support to the Districts. We also discussed the idea that although the Gap is a wonderful tool for the new member, we need to remember that if recovery is important to them, they will go to any length to get here. In other words, we want to keep things in perspective. We do not want the mechanics of the Bridging the Gap program to overshadow the message of Alcoholics Anonymous. We believe that the very best way to have a successful Bridging the Gap program is through attraction. Therefore, we need to encourage and support the committees who take the message inside the walls in the first place. When that is being done we believe that Bridging the Gap will take place much more naturally.

## Motion discussion and vote:

Presented by Janet H - seconded by Cindy: The Archive Ad Hoc Committee 2004-2007 recommends that Area 69 endorse Archive sponsored fund-raising events for an Archive fund to support Repository and Committee activities. Financial Impact for this change: No expense to the Area Unlimited funding potential. - After some discussion, this motion failed.

Presented by Janet H - seconded by Lana: The Archive Ad Hoc Committee 2004-2007 recommends that Area 69 endorse individual contributions from AA members for an Archive fund to support Repository and Committee activities. - After some discussion, this motion failed.

Presented by Janet H - seconded by Lana: The Archive Ad Hoc Committee 2004-2007 recommends that Area 69 endorse contributions form non-area funded AA events (roundups, campouts, long-timer meetings, District donations, etc.) for an Archive fund to support Repository and Committee activities. Financial impact for this change: No expense to the Area Unlimited funding potential. - After some discussion, this motion failed.

Presented by Andy B. - seconded by Sherrie P. A motion to combine the Fall Workshop and December meeting (Area Inventory or Pass the Gavel). Having a 2 day event on the $1^{\text {st }}$ weekend in December combining Fall Workshop and Area Inventory or Pass the Gavel on Saturday. Then finish with Area Business on Sunday. Savings to the Area: lodging, mileage, postage, copying, etc. Financial Impact: Area lodging alone $\$ 600.00$ plus savings in mileage could be as much as $\$ 1000.00$ per event and as little as $\$ 400.00$ plus. Not to mention savings on postage and copying at savings of $\$ 200.00$ plus. - Motion was table.
