Minutes Utah Area 69 Fall Workshop November 6 and 7, 2010 Arandas' Xtreme Gym (White Metal Building in Back) Sunset, Utah District 12

Welcome Charlie G., Chair – with a moment of silence, followed by the Serenity Prayer, Preamble and Anonymity Statement. Welcome newcomers to their first General Service Meeting.

12 Concepts read by Jose Luis B., District 12.

Minutes of the "Pre-Assembly Workshop" August 14 to 15, 2010 – Walter C., Area Secretary – Approved as read.

Financial Report – Pete G., Treasurer, Approved with amendments.

Delegate Report – Monte S. – Bienvenidos everyone! Sunrise over Sunset, Utah begins an historical day for Alcoholics Anonymous in Utah. This weekend District 12 hosts Area 69 for their first time ever. Just over 5 years ago our linguistic district was welcomed into the General Service structure of Alcoholics Anonymous Area 69. Together we have been finding solutions for carrying the message to alcoholics in two languages and cultures. During planning meetings for this weekend, we discussed what topics might be relevant and helpful to the Spanish Speaking Community. It was unanimous that most of the issues facing A.A. today are not unique to any particular language or culture and that the workshop/discussion topics brought forward from the 60th General Service Conference (GSC) would be excellent choices for our sharing. Since leaving the Fall Assembly in Richfield, Utah, my schedule has not slowed to any noticeable degree. I was asked to share at the Idaho fall Assembly in Boise last month and instead of presenting delegate reports I have been asked to participate in District elections and help with a Home Group inventory. On the Sunday afternoon ride home from Richfield, Patti and Gay W., Sheryl T., Charlie G., Rod B., and I stopped by the new Spanish Speaking Intergroup office. District 12 was holding their elections and had asked for someone from the area to offer some remarks on the importance of General Service. None of us had any idea of the interest that request would generate. Congratulations to all of those who were elected to serve Alcoholics Anonymous General Service in their Home Groups, Districts, and Area. You are the direct communication links between our Fellowship, the General Service Office/GSC and the alcoholic who still suffers. May God bless your every effort. If there is anything I can do to make your job easier, please call? Walter C., (Alternate Delegate elect) Sheryl T., (Area Secretary elect) and I also dropped by the 5th annual Spanish speaking convention in Salt Lake City. Grupo Hispano hosted a lunch that was delicious. Walter has hit the ground running, visiting District 12 and getting ready to assume his duties as liaison with District 12. Keith M., Panel 61, Area 69 Delegate asked me to begin preliminary arrangements for Area 69's bid to host the 2015 PRAASA. The 2015 PRAASA host selection will be made during a Pacific regional luncheon at the 61st GSC. We had the pleasure of being invited to the home of George S. He is Area 69 Panel 21 Delegate and he is 91 years old. Along with George's Sponsee, John, Charlie G., Area 69 Chair, Sheryl T., Area 69 literature Chair, there were 4 generations of Area 69 past and present delegates in George's living room. Panel 21, George S., Panel 39, Patti W., Panel 43, Gay W., and Panel 59, Monte S. Thank you Tiny for arranging that spontaneous reunion. The Grapevine/LaVina and e technology surveys have been submitted to headquarters to be added to others collected from throughout the U.S and Canada. Results should be available after the first of the year. Utah had approximately 50 responses to each survey. Thank you District One for making the GV/LV survey available on the front page of "Pass it On Newsletter"! Thanks again to Pete G., and Charlie G., for collecting and compiling our Area's e technology information. It isn't often that we are asked by the GSO/GSC to participate in decisions on a fellowship wide basis. Thanks to those who were able to participate. I have forwarded our Grapevine/LaVina survey forms to our area archives. The Corrections Desk continues to seek sharing from members going into correctional facilities who are finding solutions to some of the rules and regulations associated with doing 12 Step work in jails and prisons. Jim M., who sits on the corrections desk, says "thanks to Fellowship efforts", the number of vet-to-be-linked A.A. members on the "inside" has been cut in half. However, we still need new volunteers for our Corrections Correspondence Service - every day new requests come in from men and women who trust that the hand of A.A. will be there". Last month the Public Information desk released a link to the GSO website and the newly Conference approved Animation Video. This new 12th Step tool is remarkable and I am showing it to all of my children and grandchildren as a prevention and resource tool. You can go to "aa.org" and follow the prompts to view the new Animation video. Work continues on draft version of the pamphlet "A.A. Members-Medications and Other Drugs". There is additional behind-the-scenes work being done on developing a process for the GSC inventory and for Concept V appeals process. At last report our from A.A.W.S. Highlights, net sales were 13% under budget and contributions were 2% over budget. Operating expenses were 8% less than budgeted as the GSO has been looking to less costly ways of getting material ready for printing as well as other cost containment efforts. The report did not reflect the financial results of the 2010 International Convention in San Antonio. During the convention, approximately 25,000 copies of the souvenir edition of Alcoholics Anonymous Comes of Age were sold with a limited quantity remaining for purchase. Since our "go live" date June 10th, there has been a steady increase in use of Contributions on Line. No significant problems or complaints have been reported and notes of appreciation with a few helpful suggestions for future updates have been received. As of October 20, 2010, The A.A. Service Manual – Twelve Concepts for World Service 2010-2011 became available for purchase. Also known as the "Secret Service Manual" this is one of the "More Will Be Revealed" items mentioned in our Big Book. Every week or so I receive a packet of information from the GSO called a 'cubby hole mailing'. In it are all sorts of memos and information. The most important document I received is the New Group Form Applications. Our Area has continued to add meetings and groups this past two years. A couple of months ago

I received a New Group Form that turns out to be more of a support group for clients at a County Health facility. The meeting I attended was being facilitated by two members from Narcotics Anonymous. The program at this facility follows a Drug Court agenda. After speaking with one of the administrators and offering our cooperation, I contacted Adrienne B., at the GSO and she is mailing information about what an Alcoholics Anonymous Group is and correspondence about how we cooperate with court programs. I have also asked incoming area officers to follow through and continue our help. These types of "support group" meetings should not be listed on our meeting lists or in our directories. They do however; offer us opportunities for C.P.C. and P.I. 12th Step work.

Area Officer's Reports

Cooperation with the Professional Community (CPC), Sherrie P., Chairperson – Since the Elections Assembly I have been taking inventory and getting the CPC literature and information ready to pass onto Wade, our newly elected Area CPC Chair. I have an inventory list and the literature is ready to move. I would like to ask all of you to say a little prayer for him. He has stage 4 cancer which has gone to his brain, but he is still out there carrying the message.

Literature, Sheryl T., Chairperson – I was invited to present and provide a literature display at the District 1 Workshop in September. What a great event! I was impressed with the turnout and the participation. I had not been to Valley Camp since early in my sobriety, so being there around a campfire again was kind of a spiritual experience! Another fairly substantial literature order was just placed and received. Unfortunately, the new version of the Service Manual was not yet available at the time the order was placed, so I do not have the updated Service Manuals today. I plan to have them in Moab. I will place one more small order before the end of my term as Literature Chair. Please let me know if you have literature needs by November 17th. I will deliver the ordered items at the Moab event or can make other arrangements if you will not be in Moab.

Public Information (P.I.), Andy B., Chairperson – Since my last report in August, I have had opportunities to be involved in 2 Recovery Day Events in September and a Health Fair at BYU in October. All events were very well attended. The BYU event was several thousands of people in 3 hours. I talked to a lot of people that night, and they almost totally wiped out the literature I had taken with me. I also gave out hundreds of the "AA at a Glance" and the "Information on Alcoholics Anonymous." At these events, you would not believe how much people open up when they are handed some pamphlets, or literature, and I also love sharing what little I know about recovery and our great Fellowship with anybody who's willing to ask. After all I have learned there are no stupid questions when it comes to recovery. As always it's a privilege to serve. Thank you all so much. I have been elected to do the District 10 BTG coordinator, and I am looking forward to serving at the district level again.

Treatment Facilities, Bruce I., Chairperson – The district treatment chairs I have talked to are doing well. Several district treatment chairs have recently been voted in. A couple of them, Districts 2 and 3 came in to finish the current rotation and will carry over to the next. Overall their reports suggest that current AA members continue to show up at treatment facilities and offer our program to new prospects. The relationship we have with facilities is sometimes a little uncomfortable for both the institutions and AA members. Both are offering the alcoholic a solution. From time to time it creates a little tension. We have to continue to guard our Traditions without being aggressive or offensive. My final project for treatment is under way. We are developing a list of facilities in Utah and gathering information about the type of meetings or support we provide at treatment centers. In some cases we do not have a relationship. Either we have never had one or it has been suspended. We hoping to have a clearer picture by the end of the year. As

usual, most of my efforts have been directed toward Bridging the Gap. Since the Pre-Workshop Assembly we have welcomed 2 new BTG coordinators. The first was Kate I. from Cache Valley Intergroup. We have given her a BTG workbook and a brief introduction. She has reported making and distributing copies of the GSR kit. We understand she's building a volunteer base and we are looking forward to their progress. Last September Wade and I were invited to give a presentation to the Cache Valley Intergroup at one of Logan's parks. AT least 20 - 25 people showed up and they all brought food! Two local female speakers shared their desire to see BTG become established. Both of them spoke about how they wish it had been available before they were released. They said it would have made their transition to the outside much easier. One told us about a friend who eventually died and she wondered if her friend would have found a home in the program if there had been someone to greet her. Wade also shared his story with us. Afterwards several people signed up as BTG volunteers. The other coordinator is Jim D. from District 2. He is taking over for Sara L, and hopefully of his own. We especially want to thank Sara for her efforts. She served on our BTG ad hoc committee and was instrumental in helping us get this rotation jump started. We have met with Jim and gone over the basic workbook materials. He seems excited to serve. And we are excited to have so many energetic people willing to contribute their efforts towards this project. We now have six BTG coordinators around the state not counting some who are newly elected. After several BTG coordinator orientations Wade and I have decided to write one last section for the workbook. It will be a brief introduction to Utah Area 69 BTG and how to use the supporting documents. Because we have updated much of the original content and created a considerable amount of new information during the last two years it can be a little overwhelming for someone just staring out. However, we believe the system which Area 69 has developed is still far simpler and much flexible than some used in other Areas. One final project we are working on for Bridging the Gap is an updated list of coordinators and others who are directly involved. The key members who will be on this list are the Area Communications, Corrections, and Treatment Standing Chairs; the District BTG Coordinators, DCMC or DCM, Corrections and Treatment Chairs; and hopefully a couple of long term contacts. It will also include the Central Offices and Intergroups. This list will be circulated among the members on the list and will be attached to the Area 69 directory in the future. Central offices and Intergroups, represent a somewhat untapped part of the network. We have been talking to them off and on during the past year and are developing a closer association. We are excited they are willing to join with us. Hopefully we will have things worked out by the end of this rotation. One of the things they offer is stability. They have a more permanent location and seem willing to allow us to share it. Putting contact information on our literature such as the pamphlets has been problematic. In most cases the information is only good during a two year rotation. They seem willing to become a relay point as long as we provide a current coordinator list so they can forward the requests that come in.

Amend the Area 69 Guidelines concerning "Bridging the Gap". Replace sections **4.5-c** and **4.9-c** of Area 69 Guidelines to read as follows:

Section 4.5 (new) -- c) Shares co-responsibility with the Area Treatment Facilities Chairperson in providing oversight of the "Bridging the Gap" program within Area 69;

Section 4.9 (new) -- c) Shares co-responsibility with the Area Corrections Chairperson in providing oversight of the "Bridging the Gap" program within Area 69.

Section 4.5(to be replaced) -- c) Encourages committee members to become familiar with "Bridging the Gap" and other AA programs designed to help inmates.

Section 4.9 (to be replaced) -- c) Encourages committee members to become familiar with and to use the "Bridging the Gap" and "Temporary Contact" programs.

Financial impact: probably reduced overall because of joint effort.

Date of motion: 6 November 2010

Rational for motion: The current guidelines do not suggest who is responsible to organize, adapt and manage "Bridging the Gap" within Area 69. The sections to be replaced simply ask the Corrections and Treatment Standing Chairs to encourage and familiarize their committees. The program clearly needs leadership. It is meant to benefit those target populations so it is natural for the Corrections and Treatment Chairs to provide oversight. As Co-chairs they can efficiently blend their efforts and eliminate duplication as well as provide frontline supervision. At this particular time it does not appear necessary to create a specific committee or chairperson to oversee "Bridging the Gap" if Corrections and Treatment cooperate.
