Report from Past Event

Pre-Conference Assembly, Deanna O., District 7: This year's Pre Conference, which was held in Rockville, was a smashing success in many ways. A lot of people traveled down to the warmer weather that weekend. We had 124 people register and 72 people got the banquet! By the end of Friday evening, we had 85 people registered. We used \$950 of the available \$1,000 in seed money. We returned the full \$950 plus \$1,280.07 for a grand total of \$2,230.07 returned to the Area. This was a great event that I am grateful to have been a part of. I'd like to personally thank everyone in the Area who helped me individually, the committee and District 7 to pull this off.

Registrar's Report, Sheri P., Area Registrar: I was able to email all the changes from the Pre-Conference Assembly with all the new updates. When I got elected to the Registrar position, Doug had made a motion to have the changes emailed instead of copied but to have some copies at Post-Conference. I think this was a great motion because the directory changes after every assembly or workshop. So I did make some copies to pass out at this assembly but, because of the Area's financial situation, they are not fancy and I did not make a lot. I made sure I have one for all the District DCMs, all Area Officers and all Area Standing Chairs plus a few extras. Anyone at any time can request to have the directory emailed or a copy supplied at any assembly or workshop. We can make bound copies that pages can be inserted into if this is wanted. I was asked to speak at the Heber meeting and there were young people there. That was a great experience. What an honor to speak at your Friday night speaker meeting. Thank you again for asking me. If anyone would like me to come to their districts and explain the importance of having all documentation correct for GSR, DCM, and Standing Chairs in all districts, I would be happy to do that.

Alternate Delegate's Report, Walter C., Alternate Delegate: Verbal report given.

Area Chair Report, Renae H., Area Chairperson: I want to share my humble and sincere gratitude to each and every one of you for the sobriety I have today! You have contributed in my personal recovery growth by allowing me and trusting me to serve as the Panel 61 Area 69 General Service Assembly Chair to this wonderful Utah A.A. Fellowship. What an experience this is---thank you! My report to you today mainly concerns our Area's Financial Committee's activities and efforts to develop a prudent, plan of action to move the Area's budget toward a more balanced picture of what our actual annual contributions/income are. Over the last several years we have seen a gradual decline in A.A. 7th Tradition contributions to all of the various service entities across the board. The most effective remedy is to raise awareness within the fellowship that the "dollar" in the basket today equates to approximately \$0.48 cents compared to the \$1.00 dollar value in 1987. The additional and necessary remedy is to review the way that we are spending that "dollar"---to effectively carry the A.A. message to the Alcoholic who still suffers within our area's General Service structure. In addition to the aforementioned, the Area 69 2013 Proposed Budget presented today by our Area Treasurer, Doug R., and the 3 Area Motions that are currently scheduled for the Assembly's discussions on this afternoon's agenda, have been the result of working toward the Finance Committee's objectives in meeting the responsibilities of "financial prudence" as outlined in the Utah Area 69 Guidelines. When the Finance Committee met at the beginning of this year, a plan of action became clear to us through our deliberations and discussions, that there were 5 "charges," if you will, that we needed to meet. The first 4 are listed above. The fifth consideration we are proposing and presenting today for your consideration is as follows: 2012 Finance Committee - Area 69 Workshop Recommendation: In an effort to maximize Area 69 Workshops participation, functionality and effectiveness while exercising responsible financial prudence and budgeting, the Area Finance Committee reviewed the current Area Guidelines section 2.2 Area Workshops – "Area Workshops will be held each year which are rotated among Districts selected to host the event one year in advance. The purpose of Area Workshops is to provide a forum to discuss the General Service Conference theme and workshop/panel presentation topics for the current year. The format may include panel presentations, round table discussions, A.A. speaker meetings, ask-it-basket panels, and open mike discussions. Time should be given for Area Standing Committees to meet. The Area Committee may also hold a brief Area Committee meeting in conjunction with the workshop in order to better serve the need for communication within the Area. If an Area Committee meeting is scheduled, it will begin at 9:00 a.m. on Saturday. Workshops will begin at noon on Saturday and end at noon on Sunday. These Area Workshops are: a. <u>Pre-Assembly Workshop</u> held the 3rd weekend in August; b. <u>Fall Workshop</u> held the 1st weekend in November; and section 7.5 Travel Expense Defrayment – (As Funding Permits); Item d. – Lodging – "All Area Officers and Chairpersons of Area Standing Committees may be reimbursed/forwarded defrayment towards lodging expenses at the rate of up to \$40.00 per night---allowing 2 nights for Area Assemblies, and 2 nights for Area Workshops. One night is defrayed for Area Committee Meetings which require travel in excess of 150 miles one way. If two or more defrayed people share a room, the total defrayment paid shall not exceed the total cost of the hotel room. A proper receipt is to be submitted to the Area Treasurer." The Finance Committee discussed some options in regard to both Area Workshops with much consideration and reflection of past Workshop attendance---particularly the decline of participation on the Sunday portion of these events---and unanimously concluded to propose the following recommendation: "That the Area 69 Pre-Assembly Workshop held the 3rd weekend in August and the Area 69 Fall Workshop held the 1st weekend in November, become one day events held on Saturday. The Travel Defrayment for "lodging", outlined in the current Area Guidelines 7.5 Item d. ---specific to "Area Committee Meetings"---, would apply to both the Area 69 Pre-Assembly Workshop and the Area 69 Fall Workshop". Financial Impact: A savings of 1 night's lodging defrayment expense of the Area 69 General Service Committee, and potential savings to the Area on the amount of mileage defrayment incurred by the Area Committee as a result of reducing the event to one day. The Committee recognizes that the length (start and end times) of the workshops may need to be extended and the format/agenda be restructured to a degree in order to provide the maximum effectiveness and service to the Utah A.A. Fellowship. Foreseeably, such direction will gain clarity through discussion and deliberation within our Area General Service structure, if this recommendation becomes a motion. Respectfully submitted, Area 69 Panel 61 Finance Committee.

New Motion Presentation: John McG., GSR, District 2, made a motion to reflect the change in the length of Area 69 Workshops recommended by the Finance Committee (above). The motion was seconded by Scott of District 11. The new motion is at the end of these minutes.

Delegate Report Back 2012 General Service Conference, Keith M., Delegate: "Anonymity: Our Spiritual Responsibility in the Digital Age": It is an honor and privilege to serve you as the Panel 61 Delegate from Area 69 Utah. The following is the introduction strongly suggested on the floor and podium during the General Service Conference: Keith Montgomery, Panel 61 Delegate, Area 69 Utah, Cooperation With the Professional Community Delegate Committee Chairperson. We have no royalty or titles; however, we can get rather rigid with our little "t" traditions. Apparently, this is necessary for taping purposes. Hi I'm Keith a floor licking drunk from Moab. The floor licking term is new for me this year, however it is rather descriptive of my past behavior. The 62nd General Service Conference began with the pre-Conference meeting on Saturday afternoon April 21, 2012 in Rye Brook, New York with the Remote Communities. Five wonderful presentations were shared from the podium covering aspects of geography, language, and culture. Scott H., Area 79 BC/Yukon spoke of accessibility issue involving airplanes, ferries and skidoos. He has traveled over 30 hours in a weekend to carry our message of recovery to the still suffering. Apparently, I will need to stop whining about 8 to 10 hours in my pretty white car. Others shared and shared well about language and cultural barriers, however the common theme is one alcoholic sharing with another alcoholic and the message is carried. I have a few copies of all these presentations on the back table, if there is not enough please contact me and I will forward a scanned copy or mail them to all that request them. After the presentations we all divided into small

groups and shared in a round-robin format, followed by informative report-backs. Linda McD., Area 17 Hawaii shared on the Aloha communities and made me cry when she closed with her thoughts about the spiritual journey in the 4th dimension: she had come to last year's conference timid, inferior, and completely unqualified to be a delegate and left knowing the profound understanding that we are the delegates from the United States and Canada carrying our message of recovery to A.A. as a whole. Speaking of moist eyes, thanks for allowing me as the Area Delegate from Area 69 Utah to proclaim "Present" during Roll Call to the "62nd Annual Meeting General Service Conference" held April 22-28, 2012 in Hilton Rye Town, Rye Brook, New York. The facility is so large it is collectively called a town, walking from my room to the meetings involved numerous directional inquiries, beverage breaks, an occasional nap and considerable confusion for the first few days. Similar to last year I found the committee work the first couple of days extremely rewarding. Serving as chair was both humbling and exhilarating at the same time. Adrienne B., GSO staff secretary for CPC was simply the best of the best. We moved forward two Recommendations and three Additional Committee Considerations to the Conference. Stepping back a moment, I was a small part of a major moment. Monte S. had traveled from Utah to Florida, gathered two Past-Delegates from Utah and assisted in moving them from Florida to Manhattan, New York and then drove a rental car across New York to Rye Brook for the Opening Dinner on Sunday evening. Watching Gay W. and Patti W. listen to Rod B., our Utah raised Pacific Regional Trustee, share as the trustee key speaker brought absolute joy and was one of the best moments of my sober life. The five sober drunks from Utah were so emotional mere words could not convey our feelings of happy, joyous, and free. The first couple of days were dominated by committee meetings, first year delegate area highlights reports, board reports from G.S.B., A.A.W.S. and A.A. Grapevine, second year delegate presentations and general sharing sessions. These delegate presentations are incredible and included the following topics: 1) Still Our Primary Purpose, Terry S. Area 40 Montana; 2) Social Web Sites, Art M. Area 32 Central Michigan; 3) Young People in A.A., Ken M. Area 6 Northern Coastal California; 4) Importance of Sponsorship Gerrie D. Area 84 Northeast Ontario; 5) Service: Our Third Legacy, Steve P. Area 39 Western Missouri; 6) Spirit of Rotation, Scott H. Area 79 British Columbia/Yukon; 7) Diversity – Let's Keep our Doors Open for Any Who May Suffer from Alcoholism, Susan F. Area 49 Southeast New York; and 8) Archives – Where the Past Meets the Present, Dennis J. Area 1 Alabama/Northwest Florida. The theme, tone and focus of this year's conference is all about change, which created a slow profound paradigm shift in my understanding about our fellowship. We are at the turning point of a new vision. The words used in the General Service Structure representing this change are difficult for me to explain the spiritual feeling with our fellowship. Strategic planning, corporate restructuring, inventory, digital data, e-publishing, etc. do not convey what is happening just below the surface. Our theme "Anonymity: Our Spiritual Responsibility in the Digital Age" is at the center of our challenge. We as a fellowship need to find our path to share one to one in this brave new world and maintain our personal anonymity. Vic P. Western Canada Regional Trustee suggested in his farewell talk, "that we have been stuck for a few decades and now we have a new vision." According to Vic this began a few months ago when all parties shared openly during the General Service Board Inventory, the words are complex; strategic planning and corporate restructuring however it all comes down to honest open communication at all level of service. Over the next three years our fellowship will take our inventory and it is a good beginning to a new vision for A.A. as a whole. During the Pacific Regional lunch the 2016 PRAASA was awarded to Area 92 Eastern Washington to be held at the Convention Center in Spokane, WA. No treats were provided, however the fellowship was amazing. At 3:17 pm on April 25, 2012 I began my last deliberations as the Panel 61 Delegate, it lasted 2.5 days or about 21 hours and 15 minutes. A total of 93 delegates began gathering our group consciences on February 15, 2012 with 73 Final Agenda Items. Of these, Final Agenda Items, 37 became committee recommendations of which 32 passed with at least substantial unanimity and 57 became Additional Committee Considerations. Of these Additional Committee Considerations six "took no action" and dies in committee, all of the rest were forwarded to trustee committees for future action or deliberations. The General Service Board Motion on restructuring passed after considerable debate and revisions. The strategic plan for restructuring both corporate boards and the General Service Board has been approved and we have turned a corner on stagnation and our leaders have the potential to become visionary. The last part of the conference dealt with the dreaded Floor Actions. There were only seven, one was withdrawn as we started, two received death by "decline-to-consider", three failed after debate, and one passed. If you die your relatives can bequest up to \$5,000.00 in your name, but just once. Well, it is time for the results of the big nine Final Agenda Item that the Area 69 Utah took group conscience on and we formed an area conscience during the Pre-Conference Assembly. Our area seems to be pretty close to the middle and in general agreement on most of the important issues. Apparently we are not unique, however we are special.

Appendix F

Area 69 Standard Accounting Practices

1.1 Travel Expenses

- 1.1.1 Standing Chair travel expenses to and from Area 69 events should be accounted for under the Standing Chairs Expenses category.
- 1.1.2 Standing Chair travel expenses to fulfill the individual duties as chair of that committee, should be accounted for under the individual committee budgets. (ie. Travel to and from District Meetings and/or Workshops)

1.2 Standing Chair Budgets

1.2.1 Standing Chair budgets should have two line items. An expenses column that reflects the expenditures of the committee; including Standing Chair travel expenses as outlined in 1.1.2 above. An incoming revenue column that reports contributions or purchases generated by that committee as a result of committee activity. These contributions may include sales of AA literature, Grapevine, costs related to printing of GSO approved or Area 69 approved material, defrayment of the standing chair to a District or group event (referring to 1.1.2 above) or individual contributions intended for the use of a specific committee (contributions for Corrections or Archives)

1.3 Assemblies and Workshops

- 1.3.1 Assemblies and Workshops will be listed on the Annual Budget and/or Financial Report only to indicate the amount of seed monies needed for each event.
- 1.3.2 Each Assembly/ Workshop Hosting District is responsible to provide a financial accounting which shall include income, expenditures, and the balance. It is suggested that the host committee use the existing "Area 69 Activity Information Form" to record the event information and to provide a copy to the Area Treasurer within 60 days following the event.
- 1.3.3 The Treasurer will report on this information and provide a copy to the Area Archives.

1.4 Contributions

1.4.1 Each type of contribution source should have a separate line item. (ie. Group Contributions, Individual Contributions, Contributions Generated by Area Service Events, Contributions Generated by Non-Area AA Events, etc.)

Rationale:

On November 5, 2011 at the Fall Workshop in Murray Utah, our current Delegate suggested that, "Consistency is the best practice in accounting." This statement pointed out the fact that we as an Area do not have any standard accounting practices. This makes it very difficult, if not impossible to accurately compare income and expenditures from year to year, panel to panel. To that end we, the Area Financial Committee, are recommending the adoption of the above "Standard Accounting Practices" to be published as "Appendix F" in the Area 69 Guidelines.

MOTION- MILEAGE DEFRAYMENT

"Reduce the current rate of defrayment for Area Officers and Chairpersons of Area Standing Committees from 25 cents per mile to 20 cents per mile for distances in excess of 25 miles round trip."

Date of Motion: February 25, 2012

Presented by: LeAnn L.

Seconded by: Keira N.

Rationale/Background: The Finance Committee concluded through its discussions that the rate of 20 cents per mile defrayment for distances in excess of 25 miles round trip for Area Officers and Chairpersons of Standing Committees is financially prudent and is a reasonable defrayment rate to off-set the expense of travel within the Utah Area 69 General Service structure. Based on Area 69 Archives records dating back to 1982 through 1989, the defrayment rate was 10 cents per mile; from 1990-2007 it was 15 cents per mile; from 2007 to the current time, the rate has been 25 cents per mile. The 2007 increase of 10 cents per mile was affected in part by the rising cost of fuel associated with the economic climate during that time. It was the Finance Committee's consensus that the current rate of 25 cents per mile has basically covered the total expense of actual fuel costs incurred (associated with the travel of Area Trusted Servants) in most cases. This may vary with the type of vehicle used for travel. Once again, the purpose of defrayment is to assist in covering a portion of expenses while serving in an Area position. The financial impact and potential savings to the Area by reducing the current rate of 25 cents, for a savings of just "one nickel" per mile, is impressively significant. The actual annual cost of Area Service position travel is variable and fluid dependent upon the location of the hosting districts of Area 69 Service Events, as well as the amount of travel associated with Officers' and Standing Committee Chairs' levels of activity in conjunction with performing the duties of each elected position. Therefore, the annual average savings to the Area through the implementation of this recommendation will also vary.

Financial Impact: The potential savings could be up to \$1,400.00 per year.

MOTION – BRIDGE THE GAP WORKSHOP

"Discontinue having a Bridge the Gap Workshop in June each year. Instead of the workshop, in odd years of each panel at the Post-Conference Assembly, approximately one to two hours would be allotted for Bridge the Gap presentations and sharing of experience."

Date of Motion: May 19, 2012

Presented by: Mary B., Area 69 Corrections Chair

Seconded by: Wade J., Area 69 CPC Chair

Rationale/Background: Bridge the Gap is really handled by the districts. The Area is struggling financially and this could result in cost savings. Historically, there has been low attendance at the BTG Workshops. The www.utahaa.org website has BTG information, forms, etc. If the districts need help, the Area can assist.

Financial Impact: Potential savings of \$300 annually

MOTION – AREA 69 WORKSHOPS

"That the Area 69 Pre-Assembly Workshop held the 3rd weekend in August and the Area 69 Fall Workshop held the 1st weekend in November, become one day events held on Saturday. The Travel Defrayment for "lodging", outlined in the current Area Guidelines 7.5 Item d. ---specific to "Area Committee Meetings"---, would apply to both the Area 69 Pre-Assembly Workshop and the Area 69 Fall Workshop."

Date of Motion: May 19, 2012

Presented by: John McGrath, GSR, District 2

Seconded by: Scott, District 11

Rationale/Background: The Finance Committee discussed some options in regard to both Area Workshops with much consideration and reflection of past Workshop attendance, particularly the decline of participation on the Sunday portion of these events. This motion was made in an effort to maximize Area 69 Workshops participation, functionality and effectiveness while exercising responsible financial prudence and budgeting.

Financial Impact: A savings of one night's lodging defrayment expense of the Area 69 General Service Committee, and potential savings to the Area on the amount of mileage defrayment incurred by the Area Committee as a result of reducing the event to one day.
